Initial Here: _____ **GENERAL HEALTH WARRANTY:** Your pet is guaranteed to be healthy, that is to say, there are no serious health problems. Ear mites, worms, and coccidia are not serious health problems if treated and are not covered by this warranty. Hypoglycemia (low blood sugar) is a serious health problem and is not covered by this warranty, as this is generally caused by too much activity and/or too little food, which is within your control. In the event of a problem, we reserve the right to request a second option from our own selected vet, at my expense.

Initial Here: _____ **GENETIC WARRANTY:** Your pet is guaranteed against any life-threatening genetic or hereditary problems for (12) months from the time of purchase.

Initial Here: _____ **DEATH:** In the event your puppy dies within the first five (5) business days, an autopsy will be required. As a condition to the genetic warranty in the event your pet dies within twelve months from the date of purchase, an autopsy will be required from the veterinary school confirming that a genetic defect was responsible for the death of the pet.

Initial Here: _____ **EXPENSES:** In connection with all of the foregoing, under no circumstances will I be responsible for any expenses incurred by you; this includes ANY medical bills incurred by you or any other expenses with written proof. The foregoing warranties are in lieu of all other warranties, express, or implied.
